

# **Agent and Athlete Contract**

This contract ("Contract") is entered into on [Date] between Elite Athlete Management ("Agent"), represented by [Agent's Name], and [Athlete's Name] ("Athlete").

### 1. Agency Representation:

- 1.1 The Athlete hereby appoints the Agent as their exclusive sports agent for the purpose of representing the Athlete in all matters relating to their professional athletic career.

- 4.2 The Athlete shall promptly notify the Agent of any offers, opportunities, or developments related to their career.
- 4.3 The Athlete shall adhere to all contractual obligations entered into as a result of the Agent's representation.

## 5. Compensation:

- 5.1 In consideration of the Agent's services, the Athlete shall pay the Agent a commission equal to [Commission Percentage of 15% from all Entertainment Ventures, 20% from appearances and signings] of all gross earnings generated by the Athlete during the term of this Contract.
